CONTINUING EDUCATION

Texas Public Education Grant (TPEG) Application

Lone Star College is committed to student success and has dedicated resources to provide an opportunity for continuing education (CE) students to enroll in specific continuing education courses. CE students are not eligible for Title IV aid and may not receive financial aid for both CE and credit. Students taking both credit and non-credit classes may receive Title IV aid (Pell grant, loans, etc.) as long as they are enrolled in credit classes. If a student receives Title IV aid and is not enrolled in credit classes, they will be required to pay back the institution. If eligible, CE students may be able to receive Texas Public Education Grant (TPEG) funds. TPEG provides assistance to students with financial need. TPEG funds are limited and awarded by semester. Students are expected to pay a prorated cost of the program enrolled. To qualify applicants **must**:

- Be Texas residents, (limited funding for non-residents or foreign students).
- Show financial need.
- Register for the Selective Service, unless exempt.

How to Apply for TPEG

TPEG applications **must be submitted a minimum of two weeks before the start of class for each semester enrolled or 100% payment must be made at the time of registration.** Students must be pre-approved for this grant by the financial aid office. Funds are awarded on a first-come first-served basis until allocated funds are depleted. To apply, **students must follow the following Checklist:**

- Visit** the Continuing Education for CE Quick Admission.
- Complete** the online FAFSA at www.fafsa.ed.gov. *Note: If a student is selected for a process called "verification" he/she will be required to submit financial documentations directly to the Financial Aid Department before the CE award will be processed. Furthermore, in rare cases, a student "may not" qualify for the CE award due to the lack of financial aid "unmet" need. (Students are encouraged to visit their Financial Aid Department for more details!)*
- Contact** the CE Campus Office to verify eligibility. Signature of Financial aid advisor must be present to indicate TPEG eligibility and approval.
- Register** and pay your portion of tuition and fees.
