- ◆ The U.S. government requires proof of adequate financial support for all international applicants wishing to enter the U.S. on an F-1 Student Visa. Proof of financial support must be on file with the Lone Star College International Student Advisor/DSO in the amount listed at <http://www.lonestar.edu/international-tuition> at minimum to be accepted and before a SEVIS I-20 will be issued.
- ◆ Applicants with dependents will need to show extra funding per dependent in the financial documentation. The minimum amount per dependent for the current application period is published at www.lonestar.edu/international-tuition
- ◆ All students will be expected to pay tuition and fees by the scheduled due date and are responsible for his or her living expenses. The mandatory health insurance costs must be paid directly to the Lone Star College-approved Student Health Insurance Plan (SHIP) Administrator each semester before registering for classes. Please see the estimated cost of attending Lone Star College located at <http://www.lonestar.edu/international-tuition>. This amount is for two semesters. Applicants requesting to start in the summer must show additional funds as indicated in the notes. Tuition and fees, estimated expenses, and mandatory medical insurance fees are subject to change.
- ◆ Students who intend to pursue a degree may be required to take English language, developmental education, or other prerequisite courses depending on their placement test scores. This will incur additional costs and time to complete the degree. Plan for additional expenses.
- ◆ Federal financial aid is not available for F-1 international students.
- ◆ Employment in the United States is not allowed unless it is authorized by the International Student Advisor/DSO at Lone Star College and the U.S. government.
- ◆ I, the sponsor or the applicant, hereby certify that financial support information is accurate and complete to the best of my knowledge and that I have the full amount reported below available for academic, personal, and any dependent expenses for one academic year. I understand that a similar amount will be needed for the duration of the program at Lone Star College.
- ◆ I will need to present the U.S. Embassy or Consulate with the original financial documentation as part of the student visa application.
